**Donor Update**  
**August 2021**

As well as thanking you as usual for your continuing support for the work of **Barbara Academy**, I have to report that the situation in Kenya generally has become even more challenging in recent months.

Within rural Western Kenya in particular, the rates of new **Covid-19** cases and deaths have risen sharply in recent weeks, prompting the Kenyan Government to impose further restrictions in the local area. Churches were closed for some time and the night time curfew extended, but schools remain open after the extended closure in 2020. With less than 3% of the population fully vaccinated and limited access to health services, Kenya is typical of many countries in Africa and elsewhere in the world.

There are also increasing signs that **Climate Change** is disturbing the previously predictable pattern of rainy seasons, which are critical to the subsistence farming activity, on which many in the local population rely to feed their families.

I am pleased to report that no **Covid-19** cases have occurred at **Barbara Academy** so far, which is a testament to the strict measures implemented by **Edward Wata** and his team to create a **Covid-19 secure environment**. Sadly, at least one parent of a school pupil has died in recent weeks.

**Barbara Academy** opened at the end of July to start a new school year and continues to expand with the addition of a further year group, who are occupying our latest new classroom (picture shows construction phase).

Thanks again to the great efforts of **Edward Wata** and his team, **Barbara Academy (full name Barbara Leighton Academy)** was granted Full Registration status in April by the Ministry of Education. However, this will be subject to review in five years and officials have suggested improvements, which they would want to see in due course. These will need to be addressed with implications for our future funding requirements.



Further staff changes at **Barbara Academy**, including the appointment of a very experienced Head Teacher, have ensured the continued strengthening of the **Teaching Staff Team**.

As many of you already know, **YAWOSUP (Yala Widows & Orphans Support Project)** is our Project Partner in Kenya, led by **Edward Wata**. **YAWOSUP** is also a **Mission Partner of Ashtead Parish Church**, which funds other important **YAWOSUP** project work.
